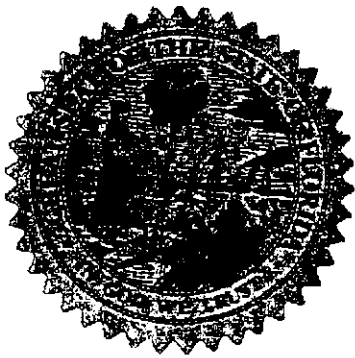
I, Jeb Bush, Governor of Florida, by virtue of the authority vested in me by the Constitution and Laws of this State, do hereby commission
