## What is a Commercial Affidavit of Truth ?

The Commercial Affidavit of Truth (CAT) is based on International Treaties

International Treaties over-ride a Nation State. 1. **14 Additional Pages From Michael Grady** (All Signatures in Green with Red Thumb Print) (10 MB Download) This is the implementation document or instructions and orders for the 50 page CAT. Be sure to retain a true and correct copy of the receipt documenting the order has been entered into your case record. .... After entering the 50 page CAT... store both receipts in a secret and safe place out side your home.
2. **Download LEE COUNTY FLORIDA 07-06-2004 CAT - 600 DPI Scan PDF 4 MB File** If the Commercial Affidavit of Truth is not available or on file in your state Michael Grady says to use the LEE COUNTY FLORIDA 07-06-2004 CAT.
3. Michael Grady has noticed in your state or region many Law Firms who are members of the " United States Law Firm Group ". This paper work is usually 14 to 16 pages in length and is to be added behind the Multiple Signature Page of the implementation document (order and demand to.... or instructions for the 50 Page CAT).
4. After securing a True and correct certified copy of the 14 page implementation order and the 50 page CAT your should take these to your deed of recorders office and enter them into the public record.
5. After completing the above and obtaining both a receipt and a true and correct copy of both these documents you have placed on the public record .... you should now have copies of each with Two Seals .... One from the set recorded in your docket and another seal from the deed of records department.
6. Store all receipts in a safe place out side your home.
7. Be sure and read and understand the multiple signature page (page 14 of the order). All who want to be a party to this may sign additionally.
8. Do not mark on or de-face any documents with Book and Page numbers.
